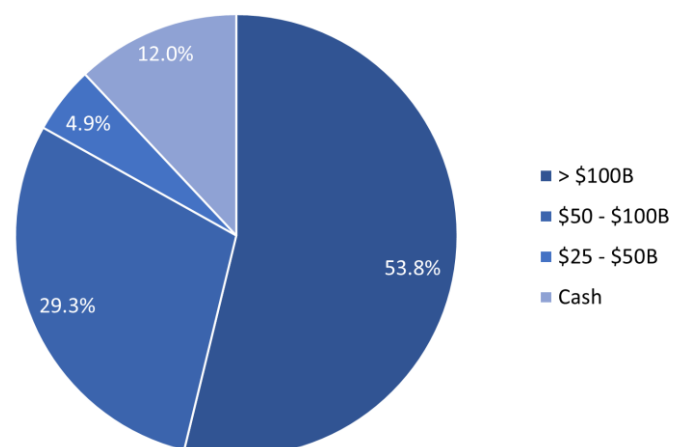

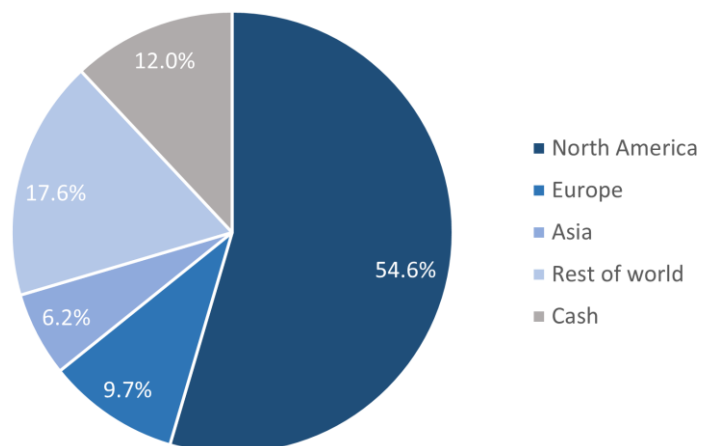
Portfolio performance since inception
